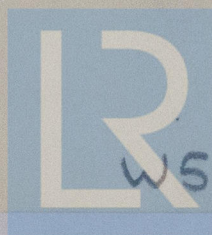

- D. Statement of Mr. C.A. Millar with photostat of survey report attached.

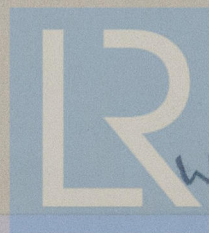
/ We also enclose:-

- E. Bundle of photostatic copy of survey reports. These we understand include all the survey reports since March 1933 (other than those annexed to the Statements of witnesses) but from what we know of the present intentions of the Board of Trade it seems unlikely that any of them will be required at the enquiry. But our clients have had these copies made in case they may be wanted.
- F. Photostatic copy of particulars of the survey for freeboard made on the 15th April 1932.
- G. Copy of a note made by our clients with regard to the various surveys.

From what we learn from the Board of Trade it seems pretty clear that the evidence to be given by the four surveyors is really formal evidence only and that no attack

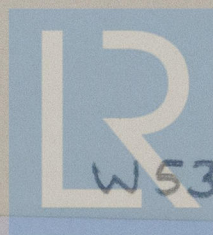
