If the openings are not so protected are the exposed parts of the Casings efficiently constructed? *-*

Give thickness of plating; scantlings and spacing of Stiffeners *-*

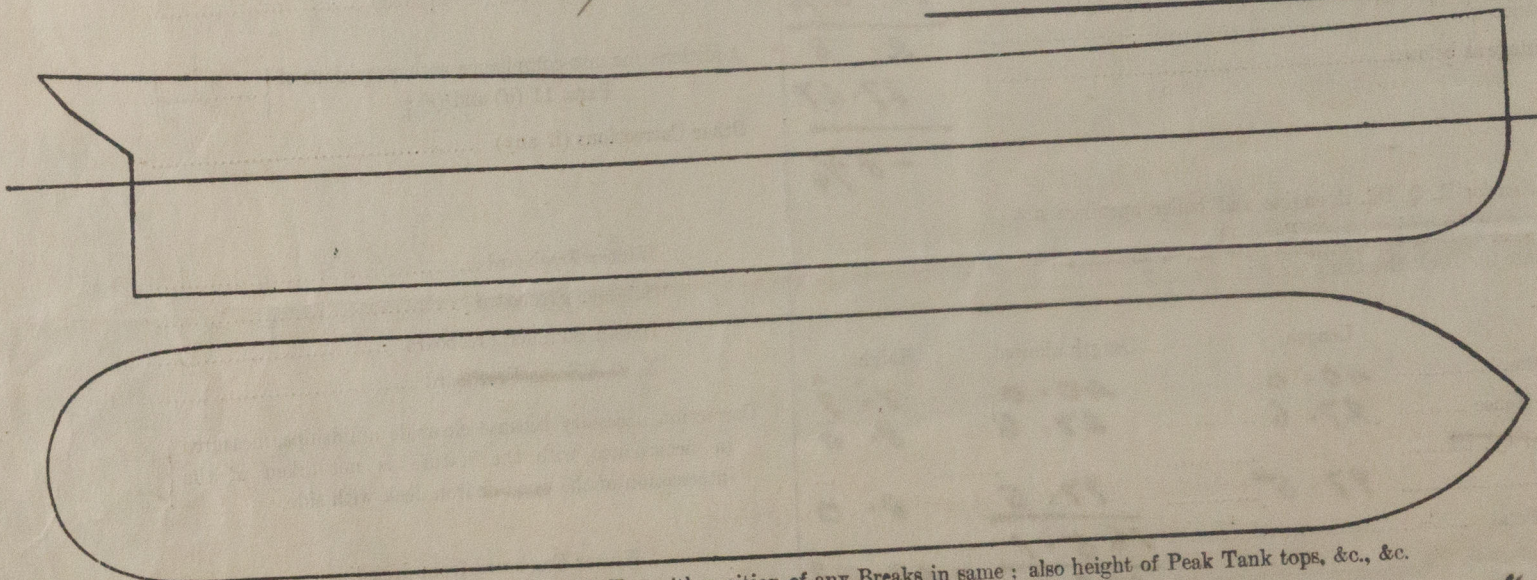
