Drillings at ends to be made in the vicinity of the peak bulkheads.


The Antwerp Surveyors report this vessel placed in dry dock and the requirements of the 2nd S.S. No.3, due 3,33, partly complied with.

The shell plating has been drilled with results as shown above, which are satisfactory.

The bottom has been cleaned and coated and repairs and renewals effected to framing, bulkheads, deck &c.

Further repairs are required to framing, bulkheads, decks, casings &c.

Damage through striking a dock wall and cause not stated repaired as follows:- 1 shell plate partly renewed, 2 frames faired and
