## DESCRIPTION OF DYNAMO, ENGINE, ETC.

One single cylinder double acting open type vertical engine direct coupled to a continuous current compound wound dynamo  
 Capacity of Dynamo 60 Amperes at 100 Volts, whether continuous or alternating current continuous  
 Where is Dynamo fixed in Engine Room Whether single or double wire system is used double  
 Position of Main Switch Board near dynamo having switches to groups A B & C of lights, &c., as below  
 Positions of auxiliary switch boards and numbers of switches on each Each light & group of lights provided with switches as required

If fuses are fitted on main switch board to the cables of main circuit Yes and on each auxiliary switch board to the cables of auxiliary circuits Yes and at each position where a cable is branched or reduced in size Yes and to each lamp circuit Yes

## DESCRIPTION OF CABLES.

Main cable carrying 60 Amperes, comprised of 19 wires, each 16 S.W.G. diameter, .06000 square inches total sectional area  
 Branch cables carrying 22 Amperes, comprised of 7 wires, each 16 S.W.G. diameter, .02214 square inches total sectional area  
 Branch cables carrying 12 Amperes, comprised of 7 wires, each 18 S.W.G. diameter, .01246 square inches total sectional area  
 Leads to lamps carrying 6 Amperes, comprised of 1 wires, each 18 S.W.G. diameter, .00781 square inches total sectional area  
 Cargo light cables carrying 4 Amperes, comprised of 168 wires, each 38 S.W.G. diameter, .00552 square inches total sectional area

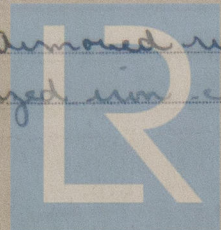
Vulcanized india rubber taped & braided & lead covered where exposed lead covered & steel armoured

Joints in cables, how made, insulated, and protected no joints except mechanical ones

Are all the joints of cables thoroughly soldered, and the flux used not containing acids or other corrosive substances Yes Are all joints in accessible positions, none being made in bunkers, cargo spaces, or spaces which may at any time be used for carrying cargo, stores, or baggage Yes

The copper used is guaranteed to have a conductivity of not less than that of the Engineering Standards Committee's standard, and the wires are protected by tinning from the sulphur compounds present in the insulating material.

Insulation of cables is guaranteed to have a resistance of not less than 600 megohms per statute mile at 60° Fahrenheit after 24 hours' immersion in water, the test being made after one minute's electrification at not less than 500 volts and while the cable is still immersed.

The foregoing statements are a correct description of the Electric Light installation fitted by us on this vessel and we declare that it is at this date in good order and safe working condition.

Distance between dynamo or electric motors and standard compass 96'

Distance between dynamo or electric motors and steering compass 88'

The nearest cables to the compasses are as follows:—

A cable carrying .6 Amperes 12 feet from standard compass 6 feet from steering compass

A cable carrying .6 Amperes 6 feet from standard compass 12 feet from steering compass

A cable carrying — Amperes — feet from standard compass — feet from steering compass

Have the compasses been adjusted with and without the electric installation at work at full power yes

The maximum deviation due to electric currents, etc., was found to be nil degrees on all course in the case of the

standard compass and nil degrees on all course in the case of the steering compass.
