NOW DONE:- Examined the Donkey Boiler under steam and adjusted the safety valves as above.

General Observations, Opinion, and Recommendation:— The machinery parts seen are in good and efficient condition and eligible, in my opinion, to remain as classed and to have a fresh record of D.B.S. 2-32, as previously recommended (See Genoa Report No.12322).
