With reference to your letter of the 5th ulto. we now beg to advise you that the above vessel has been sold for breaking ^{up} purposes with delivery at Osaka, Japa.

Our intention is to send the vessel from Singapore as soon as possible with a cargo of fuel oil which she has already on board. It is of the utmost importance that the vessel should leave Singapore the earliest moment and we hope in any case not later than Saturday next the 26th inst.

In these circumstances we naturally do not like to incur ~~any~~ ^{the} expense of having her boilers surveyed and we hope that your Committee will agree for the vessel to proceed without carrying out this Survey.
