Dear Sir,

We are desired by our friends, the National Steam Navigation Co. Ltd., of Athens, to request that the Chief Surveyor of your good Society be desired to state whether the "MACEDONIA", recently delivered by Messrs Sir James Laing & Sons, Ltd., of Sunderland, has in fact been constructed in the manner provided and specified for in specification, in the following terms:-

"The vessel to be built of deep bulb angle framing, instead of hold beams, thus leaving the holds clear for carrying large marble and machinery while giving increased strength. Sufficient shackles and holes for same to be arranged for trimming marble, etc."

As a matter of fact, our correspondents are inclined to query whether the vessel has been so built. Messrs Laing contend that they have constructed the vessel with deep bulb angles and web frames, and contend that this form of construction dispenses with hold beams and gives full effect to the wording of the specification.

Would you, as requested, kindly arrange for the Chief Surveyor to consider the question, and in due course favour us
