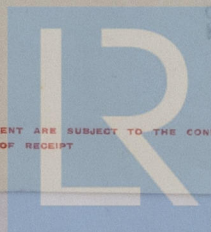
Immediately she is placed on Service we will not fail to notify you, as promised.
