We have been informed that if the boat ~~was~~ classed with you & appeared in your Register, we would be able to get her insured with Lloyds Policies more favourably than otherwise.

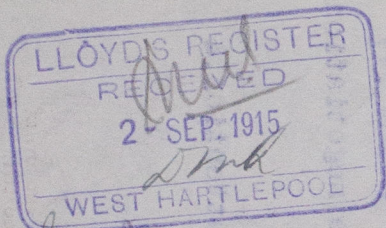
Would you oblige us with some documentary evidence to put before our insurance brokers in London, to show that we are classing her with you; such would be of much assistance to us.
