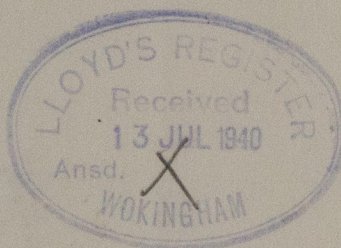

SPECIAL SURVEY NUMBER THREE PLEASE TELEGRAPH"

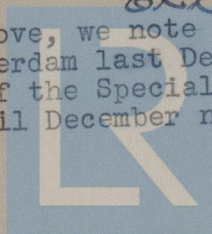
and thank you for your reply reading :-
