We received a proposal from Messrs. J. Koster Hzn. Scheepswerf "Gideon", Groningen, for 2 vessels to be built to the Society's Class. N^o 161/2

In their letter they state that a similar vessel has been built by them to the B.V. Class after the scantlings given in this plan.

As this vessel, being a shelter deck vessel with tonnage opening, is of an exceptional design and falls so far outside the Rule tables, we shall be very pleased if you will give this case your consideration and let us know full particulars.

The plan has been forwarded under separate cover to-day, in duplicate.

At the same time we shall be very pleased to hear if, with these designs, it will not be advisable in calculating the fees, to take the very large portion exempted for tonnage, into consideration, as we are in my opinion falling into extremes.
