System of Distribution TWO WIRE

Pressure of supply for Lighting 100 volts, Heating — volts, Power — volts.

Direct or Alternating Current, Lighting DIRECT Power —

If alternating current system, state frequency of periods per second —

Has the Automatic Governor been tested and found efficient when the whole load is suddenly thrown on or off YES

are their axis of rotation fore and aft YES

Earthing, are the bedplates and frames of the generating plant efficiently earthed YES are the prime movers and their respective generators in metallic contact YES

Main Switch Boards, where placed IN ENGINE ROOM CLOSE TO DYNAMO

If the generators and main switchboard are not placed in the same compartment, is each generator provided with a fuse on each insulated pole as near as possible to the terminals of the generator, additional to that provided on the main switchboard —

Switchboards, are they placed in accessible positions, free from inflammable gases and acid fumes YES

are they protected from mechanical injury and damage from water, steam or oil YES, if situated near unprotected woodwork or other combustible material, state distance of same horizontally from or vertically above the switchboards — and —

are they constructed wholly of durable, incombustible non-absorbent materials YES, is all insulation of high dielectric strength and of permanently high insulation resistance YES

if semi-insulating material is used, are all conducting parts connected to one pole insulated from the slab with mica or micanite and the slab similarly insulated from its framework YES, and is the frame effectively earthed YES

Are the following fittings as per Rule, viz.: — spacing or shielding of live parts YES, accessibility of all parts YES, absence of fuses on back of board YES, proportion of omnibus bars YES, individual fuses to voltmeter, pilot or earth lamp YES, connections of switches YES

Main Switchgear, description of switchgear for each generator and each outgoing circuit, and arrangement of equalizer switches DOUBLE MAIN SWITCH

3 FUSES FOR GENERATOR, SINGLE POLE SWITCHES & DOUBLE POLE FUSES FOR OUTGOING CIRCUITS

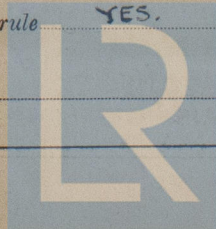
Instruments on main switchboard ONE ammeter ONE voltmeter — synchronising device for paralleling purposes

Earth Testing, state what means are provided at the main switchboard for indicating the state of the insulation of the system

EARTH LAMPS

Switches, Circuit Breakers and Fusible Cut-outs, do these comply with the requirements of the Rules YES

Section and Distribution Boards, is the construction, protection, insulation, material, and position of these as per rule YES

Insulation of Cables, state type of cables, single or twin SINGLE or TWIN are the cables insulated and protected as per Tables III or IV of the Rules. YES.

Fall of Pressure, state maximum between bus bars and any point of the installation under maximum load 3.5 VOLTS.

Cable Sockets and other connections, are the ends of all cables having a sectional area of 0.007 square inch and above provided with soldering sockets

YES

Paper Insulated Cables. *If cables are paper covered, is the dielectric at the exposed ends of the conductor protected from moisture by being suitably sealed with insulating compound* —

Cable Runs, are the cables fixed as far as possible in accessible positions not exposed to drip or accumulation of water or oil, or to high temperature from boilers, steam pipes, upakes or other hot objects, or to avoidable risk of mechanical damage..... **YES.**

Support and Protection of Cables, *state how the cables are supported and protected*..... **CLIPPED TO DECK**

If cables are run in wood casings, are the casings and caps secured by screws - , are the cap screws of brass - , are the cables run in separate grooves - . If armoured and lead covered cables are secured by metal clips, are the clips spaced as per Table VI **YES**.

Refrigerated Chambers, if lights are fitted, are the cables and fittings in accordance with the special requirements

Joints in Cables, state if any, and how made, insulated, and protected..... NO JOINTS MADE

Watertight Glands and Deck Tubes, are all cables passing through decks and watertight bulkheads provided with deck tubes or watertight glands.

Bushes in Beams and Non-watertight Positions, where unarmoured cables pass through beams and non-watertight partitions, are the holes efficiently bushed **YES.** *state the material of which the bushes are made* **LEAD.**

has each navigation lamp an automatic indicator as per Rule YES, are separate screens provided for the use of oil and electric side lights

are separate oil lanterns provided for the mast head lights and side lights.....

Fittings are all fittings on weather decks, in stokeholds and engine rooms and wherever exposed to drip or condensed moisture, watertight..... **YES**

are any fittings placed in spaces in which goods are liable to be stacked in close proximity to them ; if so, how are they protected.....

are any fittings placed in spaces where inflammable or explosive dust or gases are liable to be present, if so, how are they protected.....

....., how are the cables le

where are the controlling switches situated.....

Searchlight Lamps, No. of _____, whether fixed or portable _____, are their fittings as per Rule _____

Arc Lamps, other than searchlight lamps, No. of —, are their live parts insulated from the frame or case —, are their fittings as per Rule —

Motors. are their working parts readily accessible. —, are the coils self-contained and readily removable for replacement. —

are the brushes, brush holders, terminals and lubricating arrangements as per Rule _____, are the motors placed in well-ventilated compartments in which

inflammable gases cannot accumulate and clear of all inflammable material.

are they protected from mechanical injury and damage from water, steam or oil — are their axis of rotation fore and aft —

if situated near unprotected woodwork or other combustible material, are the motors of the totally enclosed, pipe ventilated, forced draught, drip or flame proof type

....., if not of this type, state distance of the combustible material horizontally or vertically above the motors and

Control Gear and Resistances, are the generator field and motor speed regulators, starters and controllers constructed as per Rule.....

Lightning Conductors, where lightning conductors are required, are these fitted as per Rule..... —

Ships carrying Oil having a Flash Point less than 150° F. *Have the special requirements of the Rules been complied with regarding switches, joint boxes*

section and distribution boards, protection of cables, method of distribution, lead of cables, lights and fittings.....—

Distance between electric generators or motors and standard compass 80 Feet.

Distance between electric generators or motors and steering compass 70 Feet.

The nearest cables to the compasses are as follows:—

A cable carrying 10 Ampères 20 feet from standard compass 10 feet from steering compass.

A cable carrying 6 Ampères 10 feet from standard compass led into feet from steering compass.

A cable carrying 6 Ampères led into feet from standard compass 10 feet from steering compass.

Have the compasses been adjusted with and without the electric installation at work at full power YES

Has the effect of switching on and off circuits, motors and other electro-magnetic apparatus within the vicinity of the compasses been noted YES

The maximum deviation due to electric currents was found to be NO degrees on ANY course in the case of the standard

compass, and NO degrees on ANY course in the case of the steering compass.
