Précis of particulars of Casualty

This vessel ran ashore in a fog near Aveiro on 27th June; exposed position. On 12th July it was reported she had sustained damage to hull and was holed, which seriously prejudiced prospects of salvage. Prompt sale of vessel was considered advisable.

A special casualty letter was sent to the owners on 13th July, but no reply has yet been received.

SOURCE OF INFORMATION.

REGAL. — Oporto, June 28. — Trawler Regal, Loyal Steam Fishing Company, Grimsby, ran ashore in vicinity of Aveiro during a fog yesterday, and remains. Master states considers unlikely get her off. Has brought crew Oporto, where they are billeted by Consul pending instructions. We are proceeding to inspect position. Meanwhile, master and part of crew are returning to Aveiro to protect property. — Lloyd's Agents.

REGAL. — Oporto, June 30. — Steam trawler Regal went ashore during a thick fog 3.30 a.m. June 27. Lies in an exposed position nine miles N. of Bar at Aveiro, heading south, listed seaward 40 deg. Vessel lies broadside on about 80 yards from shore at high water, high and dry at low water. Hatches washed off, vessel is full of water lying on sand, silting up rapidly. Hull apparently undamaged; movable gear, ship's stores landed in charge of Custom House authorities. Salvage practicable but difficult, prospects uncertain owing to exposed position rapidly silting up. Master and four members of crew lodged near vessel, remainder accommodated Oporto. Valkyrien, Svitzer Salvage Company, Copenhagen, proceeded from Lisbon to inspect. — Salvage Association.

REGAL. — Oporto, July 12. — Trawler Regal: Now sustained damage to hull and is holed, which seriously prejudices prospects salvage. Fear withdrawal percentage salvage proposal. Consider prompt sale of vessel as she lies advisable. — Lloyd's Agents per Salvage Association.
